A CHANGING ECONOMIC LANDSCAPE

About 21% of all people living in the five-county Austin MSA were low-income in 2023. “Low-income” is defined as people who live in a household with total earnings of less than 200% of the Federal Poverty Threshold. In 2023, low-income households earned up to \$61,800 for a family of four with two adults and two children, and \$49,098 for a family of three with one adult and two children. From 2014 to 2023, the Austin MSA grew by 590,224 people, surpassing 2 million people in 2015. This represents a growth of 31%. The number of low-income residents declined by over 56,000 in the Austin MSA, a 9% reduction, over the same time period.

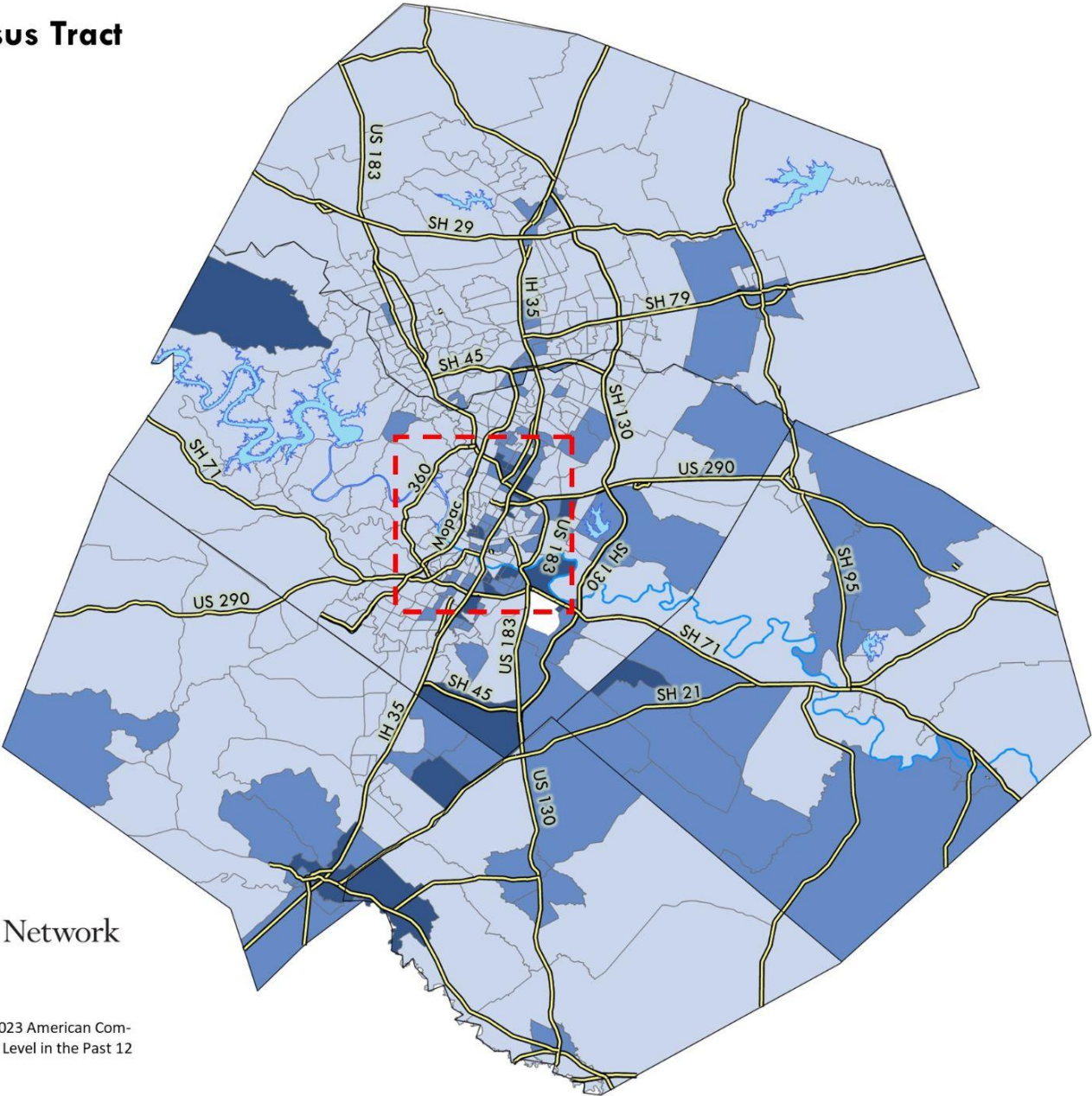
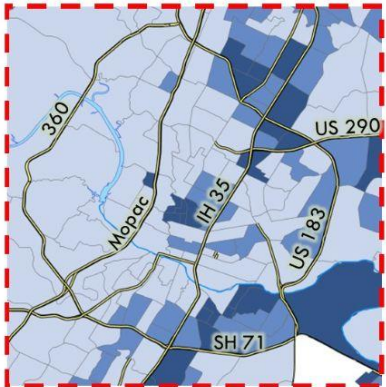

COMPARING MSA COUNTIES

Between 2013 and 2023, the low-income population decreased in the overall Austin MSA. In Travis County, low-income resident numbers dropped by 25%. Meanwhile, the low-income population decreased by 2% in Hays County and by 1% in Williamson County. In Bastrop County, the number of low-income residents increased by 53%. The estimated changes for Hays and Williamson County were not significantly different at the 90% confidence interval.

Caldwell County, the fifth county in Austin’s 5-county MSA, isn’t represented in the table because ACS 1-Year data is unavailable. The most recent estimate available for Caldwell County is an American Community Survey 3-year estimate for 2011-2013.

2019 - 2023, Austin MSA**



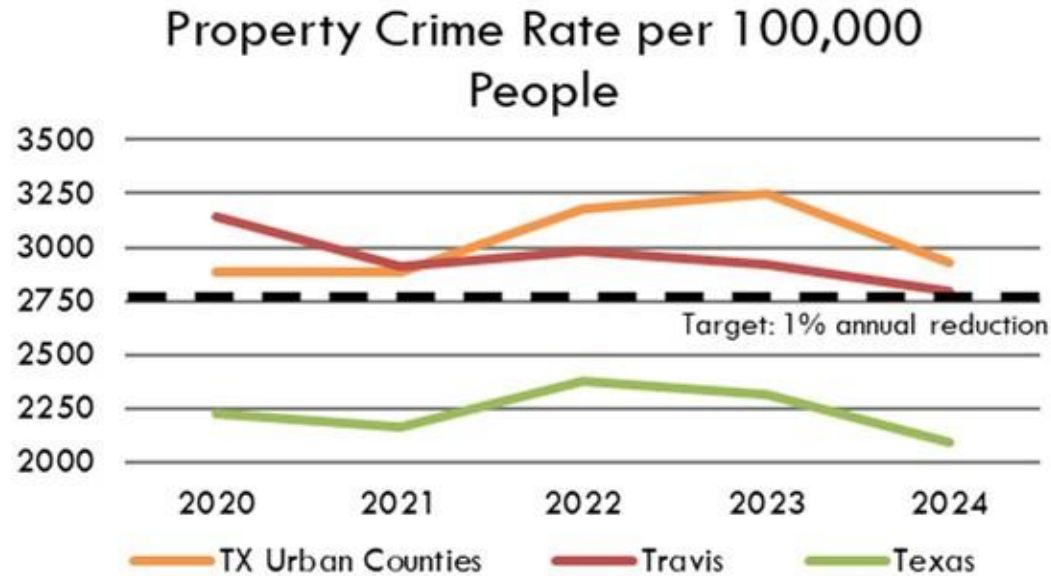

WHERE DO WE STAND?

The overall property crime rate in Travis County decreased by 11% over the past 5 years. From 2020 to 2024, larceny/thefts decreased by 15%, and burglaries decreased by 10%. Although the number of auto thefts increased by 50% since 2020, the number of auto thefts decreased by 13% from 2023 to 2024. Beginning in 2023, this measure began to include arson data for Texas and Texas counties.

WHERE DO WE STAND?

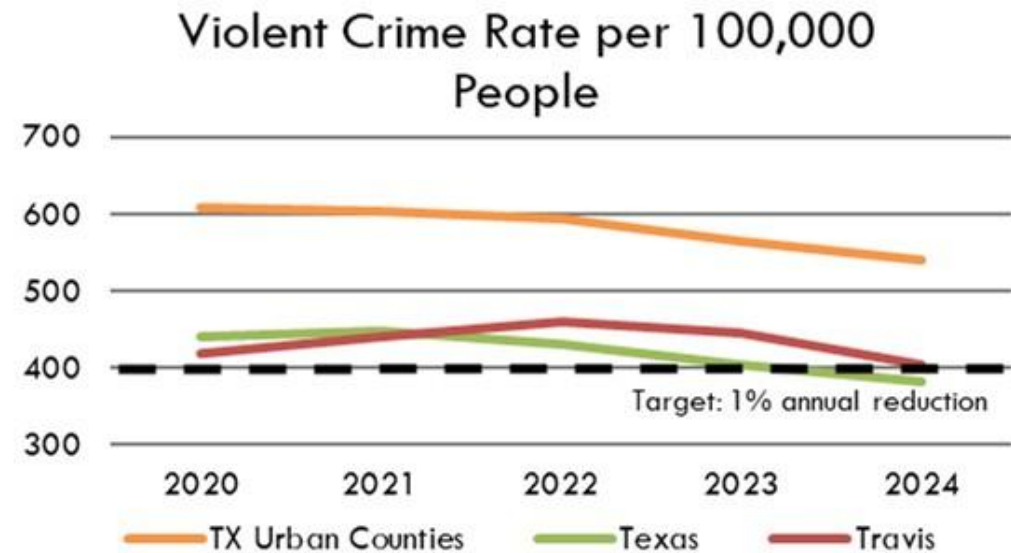
The violent crime rate in Travis County decreased by 8% from 2023 to 2024 and by 4% from 2020 to 2024. However, the Travis County violent crime rate remains lower than the rate for Texas urban counties. Over the 5-year period from 2020 to 2024, the total number of robberies decreased by 21%, rapes increased by 39%, murders increased by 36%, and assaults increased by 2%.

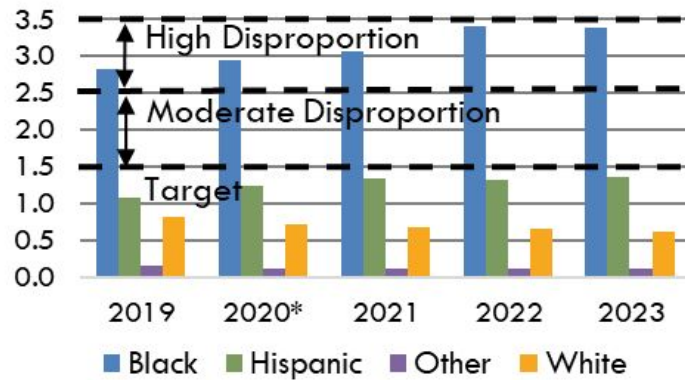

WHERE DO WE STAND?

People arrested in Travis County are generally booked into the Travis County jail. In 2023, Black residents accounted for 28% of people booked into jail, but only 8% of Travis County's adult population, which indicates a high level of disproportionate representation (3.4).

Disproportionality was also found in other CAN Dashboard indicators such as persons experiencing homelessness and placement in Disciplinary Alternative Education Programs (DAEP).

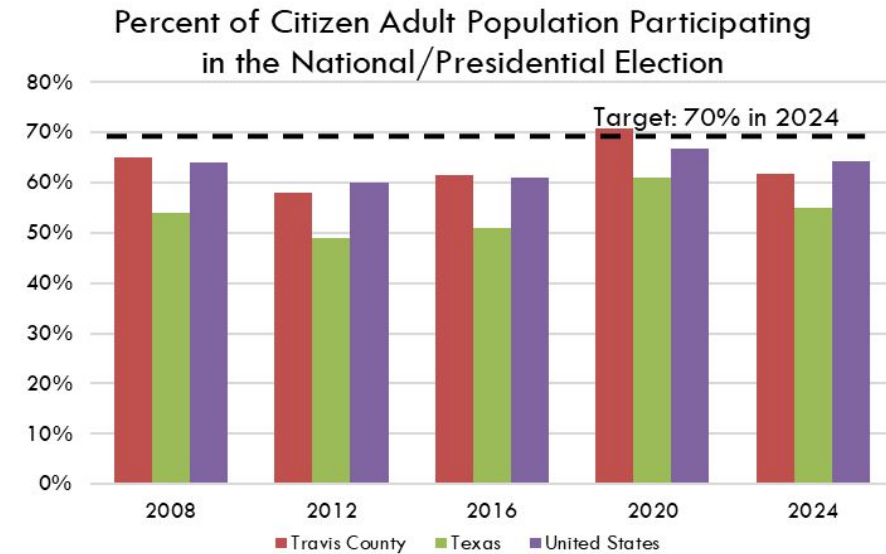
WHERE DO WE STAND?

Voter turnout of the citizen voting age population in Travis County was 62% for the 2024 Presidential election, lower than turnout for the 2020 election (71%). Total votes cast in 2024 (587,090) represented a 4% decrease from 2020 (612,696). In 2020, Travis County had a higher turnout than Texas and the USA. Travis County has a higher turnout than Texas in Presidential elections.

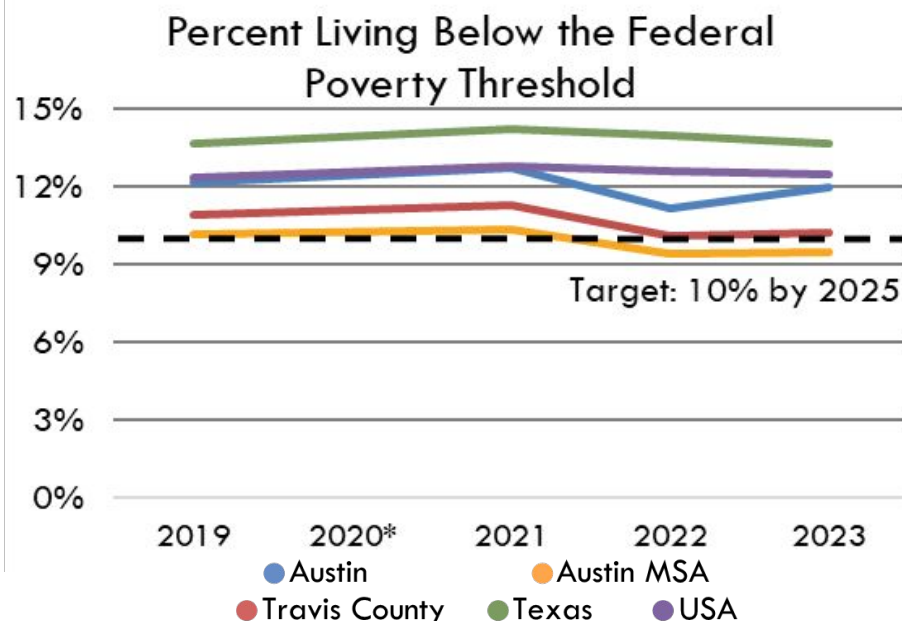

WHERE DO WE STAND?

The percentage of Travis County residents living below the federal poverty level declined to 10% in 2023 from 11% in 2019. In 2023, the U.S. Census Bureau poverty thresholds were set at \$30,900 for a family of four (2 adults/2 children) and \$25,549 for a family of three (1 adult/2 children).

There are large disparities in child poverty by race & ethnicity. Hispanic children live in poverty at more than 4 times the rate than White children do, and Black children at more than 3 times the rate White children do.

WHERE DO WE STAND?

Approximately 16% of Travis County residents faced food insecurity in 2023. That means they had limited or uncertain availability of nutritionally adequate and safe foods, according to Feeding America, the nation's leading domestic hunger-relief charity.

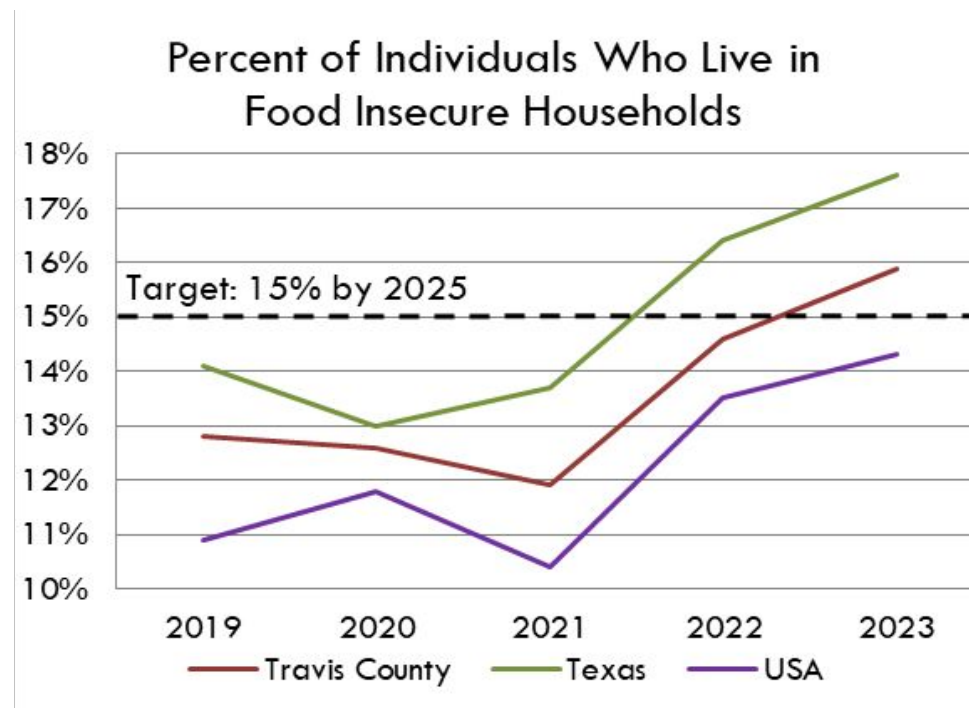
Children are more likely than adults to experience food insecurity. According to Feeding America, 16% of children in Travis County experienced food insecurity in 2023. Furthermore, the rates for African Americans (30%) and Hispanics (22%) are over twice the rate for Whites (11%).

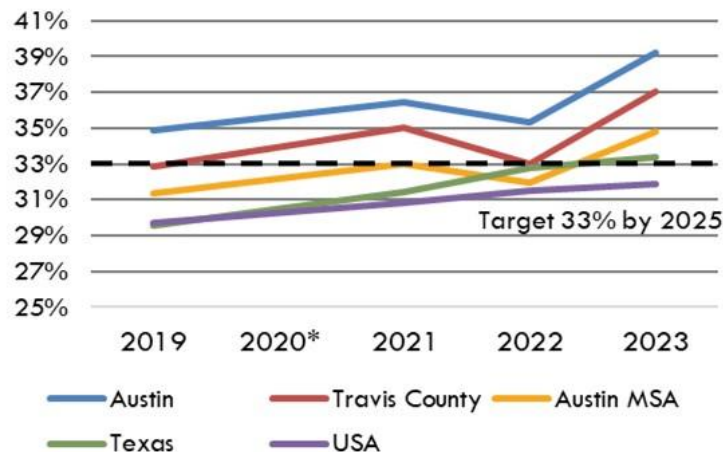

WHERE DO WE STAND?

The U.S. Department of Housing and Urban Development (HUD) recommends that households pay no more than 30% of total income on housing. More than 1 out of 3 households in Travis County do not meet this affordability threshold. The number of households that were housing cost-burdened in Travis County in 2023 was 225,569, compared to 166,989 in 2019 (a 30% increase).

Renters are cost-burdened at a rate that is almost twice that of homeowners. Low-income renters and owners are most impacted.

WHERE DO WE STAND?

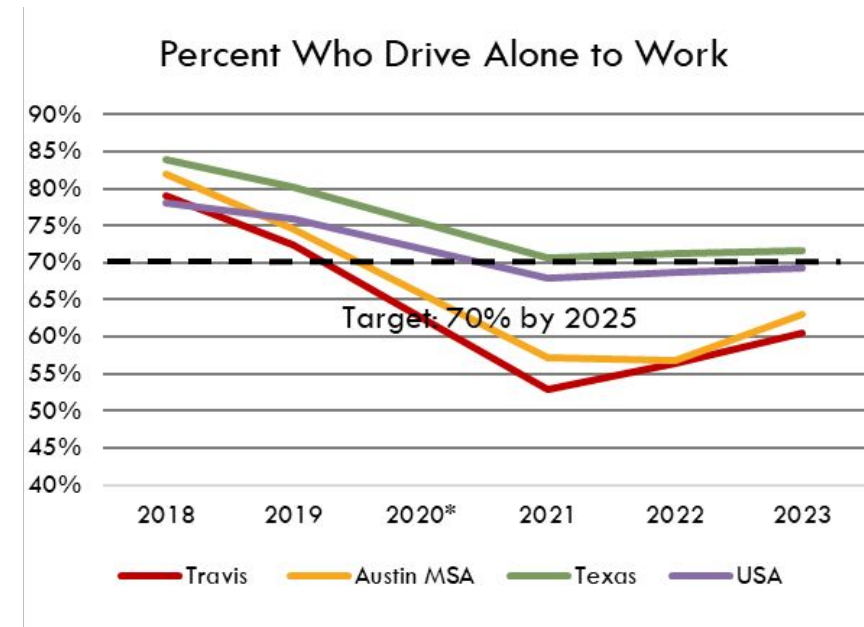
An estimated 60% of Travis County workers drove a car alone to work in 2023. Travis County has a lower percent of commuters who drive alone to work than surrounding counties, the state, and the nation. Although Austin's transit utilization is lower compared to other metro areas, it does have higher telecommuting rates. In 2019, 11% of Travis County workers telecommuted compared to 32% in 2023.

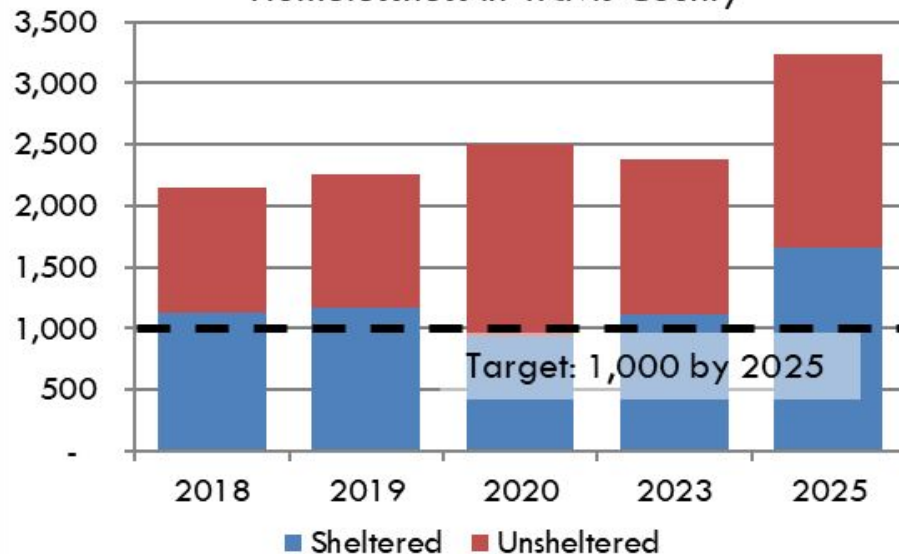

WHERE DO WE STAND?

The January 2025 annual Point-in-Time Count identified 3,238 people who were either staying in an emergency shelter, transitional housing, or who were living on the streets, in cars, or other areas not intended for human habitation. This count measures people who are experiencing homelessness on a specific day. The Ending Community Homelessness Coalition (ECHO) also reports that Black/African Americans represented 32.8% of the 2023 PIT count, but account for 8% of the Travis County population.

Due to the COVID-19 pandemic, the 2021 and 2022 PIT Counts were not carried out.

WHERE DO WE STAND?

The rate of Travis County residents under the age of 65 without health insurance was 12% in 2023, having decreased from 16% in 2019. After the Affordable Care Act was implemented in 2010, the uninsured rate began to decline locally, in Texas, and nationwide.

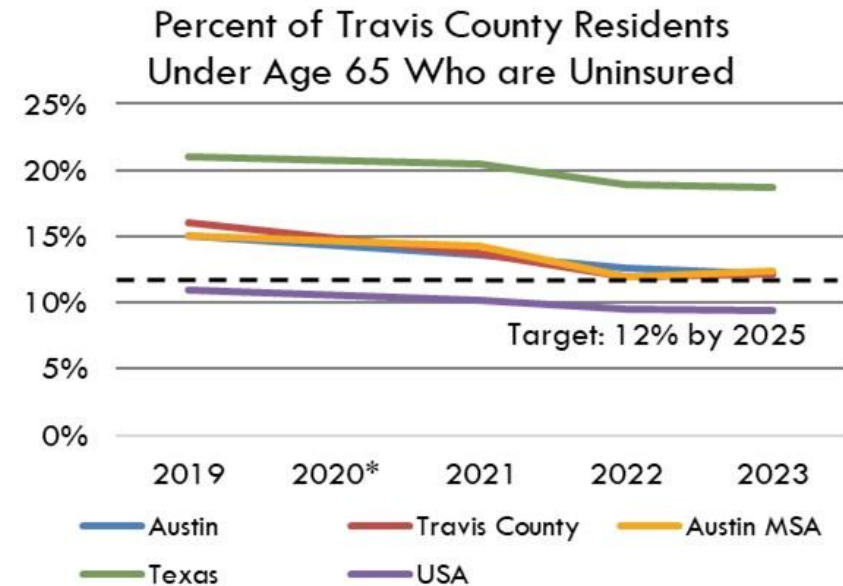
In Travis County the uninsured rate is highest for Hispanics, who are uninsured at more than twice the rate as Whites. In 2023, the uninsured rate for Hispanics was 20%, 17% for African Americans, 8% for Asians, and 7% for Whites.

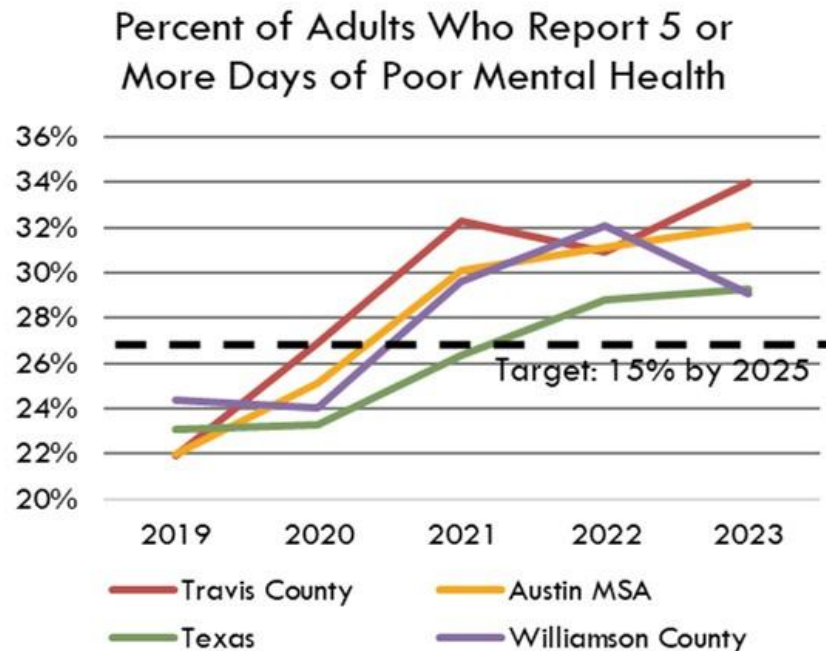

WHERE DO WE STAND?

Approximately 34% of adults in Travis County reported experiencing five or more days of poor mental health over the past 30 days to surveyors from the Behavioral Risk Factor Surveillance System in 2023, increasing from 22% in 2019. On days where someone is experiencing poor mental health, they may experience stress, depression, and/or problems with emotions.

People with a disability reported almost twice the rate of poor mental health (60%), as people without a disability (26%). Other groups with high rates of poor mental health include people between the ages of 18 and 29, people with incomes below \$25,000 and people with some college but no degree.

ARE OBESE

WHERE DO WE STAND?

An estimated 27% of adults in Travis County were obese in 2023 compared to 22% in 2019. Travis County's obesity rate is still lower than the rate for the MSA, the state of Texas and the nation as a whole.

In 2023, the following demographics in Travis County experienced higher rates of obesity: adults living with a disability, Hispanic adults, residents who are between the ages of 45 to 64, and people who are unemployed.

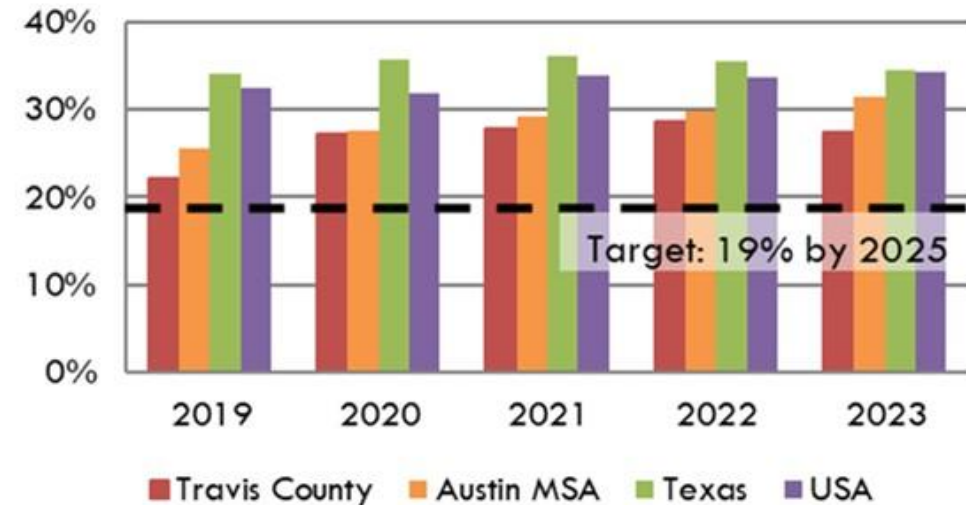

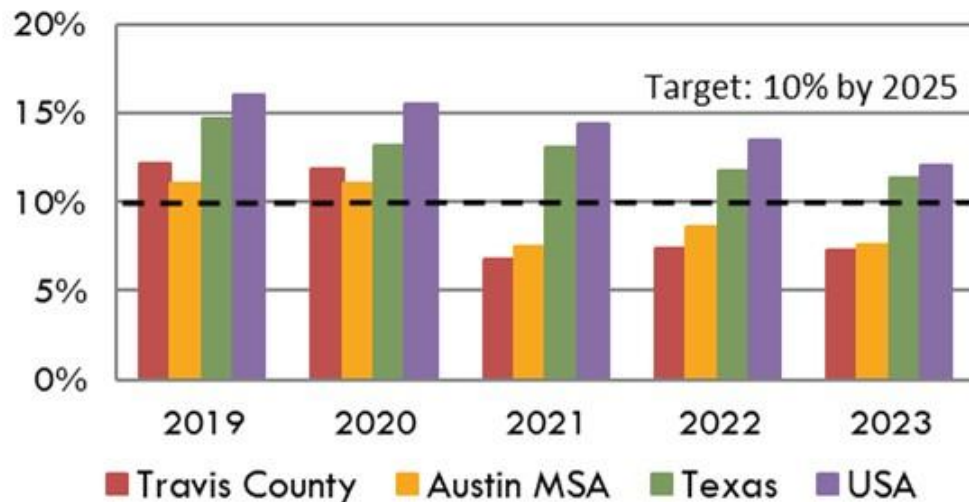

WHERE DO WE STAND?

The rate of Travis County residents who report being smokers was 7% in 2023, compared to 12% in 2019. These data do not include e-cigarette use, which has increased from 5% to 8% over the same time period.

Over the past 5 years, people with low incomes, and people who are HS graduates have been most likely to report smoking. An estimated 17% of Travis County adults earning less than \$25,000 a year, and 17% of Travis County adults with a HS diploma or equivalent reported being current smokers in 2023.

WHERE DO WE STAND?

Clean air is key to ensure quality of life for all residents of Central Texas. Over the past three years, air quality in Travis County has declined to 156 days with good air quality in 2024, compared to 182 in 2020. In 2024 there were 7 days where the air was unhealthy for sensitive groups, compared to 11 in 2023. In addition, there were 210 days when air pollution levels in the region were considered "moderate" or worse.

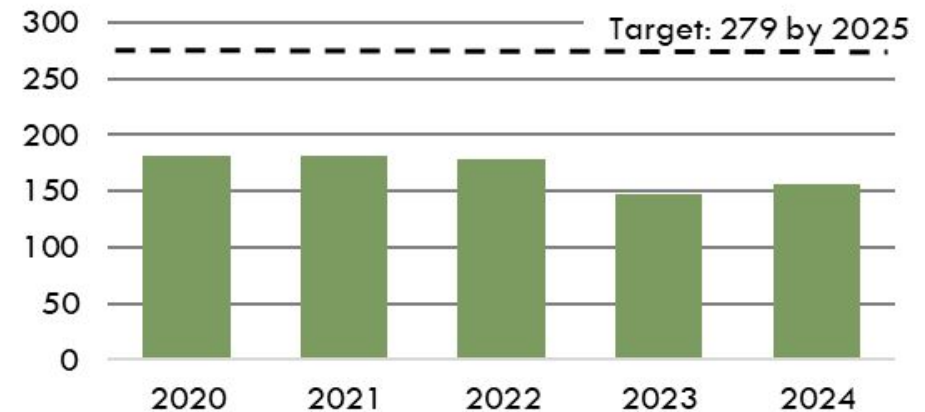

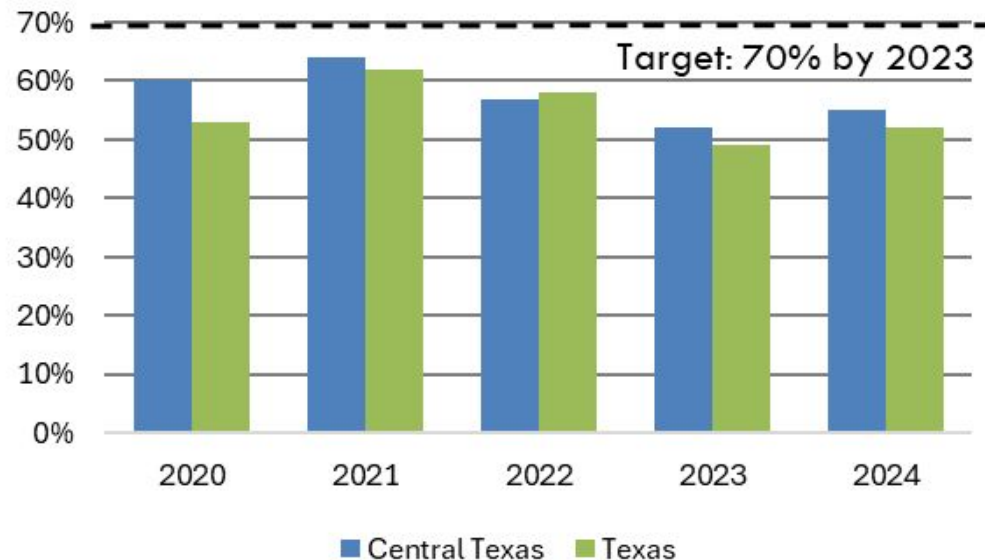

WHERE DO WE STAND?

In 2023-24, just over half (55%) of Central Texas kindergarteners were school ready according to data from the E³ Alliance, compared to 61% in 2019-20.

Almost 3 out of 4 Asian children (71%), and over half of White children (56%), were KG ready in 2023. That school year, only 50% of Black children, and 49% of Hispanic children were school ready.

WHERE DO WE STAND?

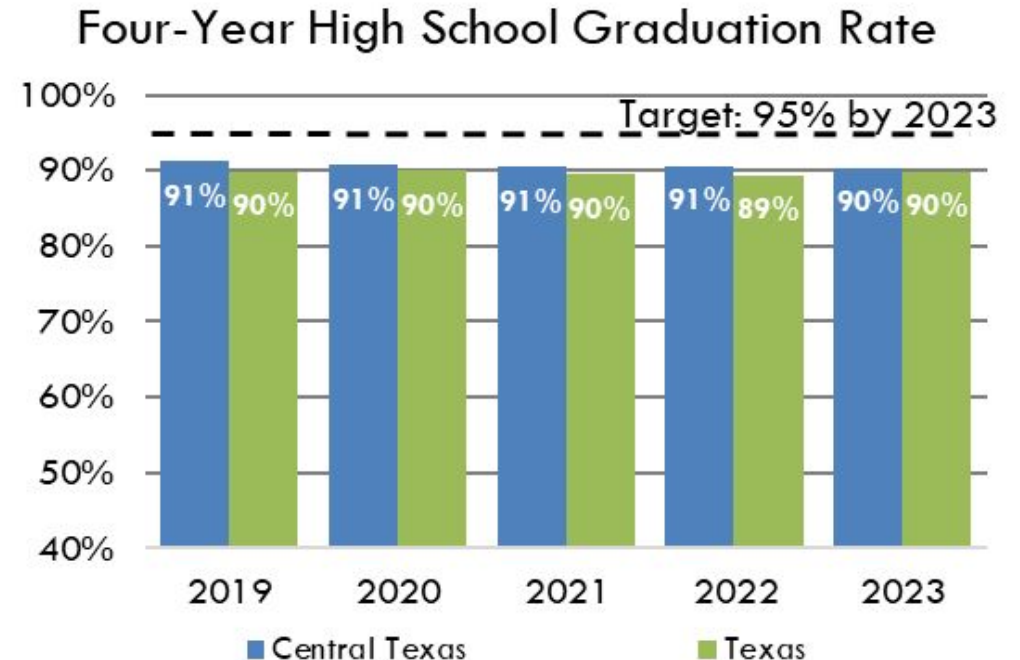
The four-year high school graduation rate for the Class of 2023 was 90%. From 2015 to 2022, the Central Texas 4-year high school graduation rate was 91%. However, Central Texas has maintained a higher graduation rate than the State since 2013. Although disparities exist by race and ethnicity, the gap has closed over the last ten years. Hispanic students saw graduation rates improve from 85% for the Class of 2014 to 87% for the class of 2023, while the graduation rate for Black students declined to 84%.

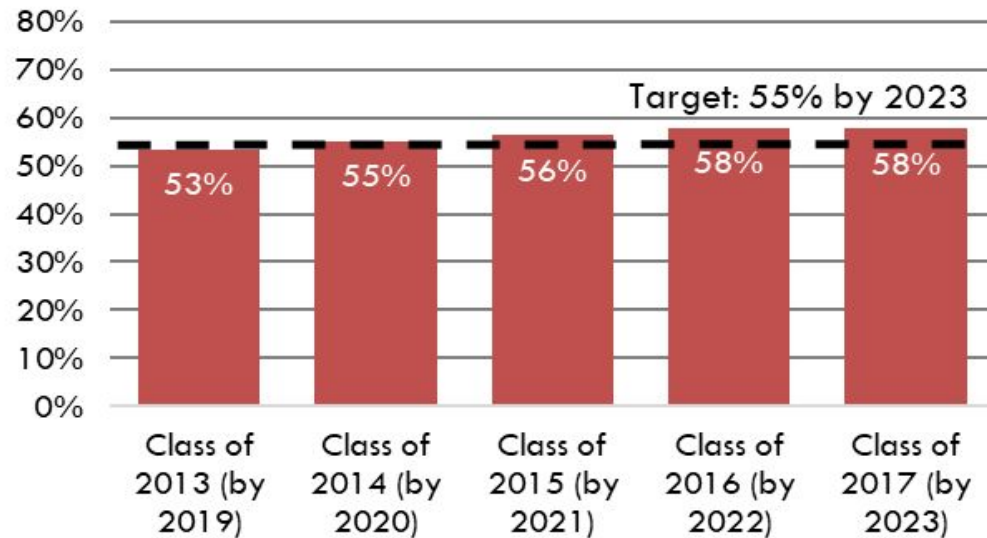

WHERE DO WE STAND?

Fifty eight percent of Central Texas students who enroll in a Texas college or university within one year of graduating from high school in 2017 earned a post-secondary credential within six years (by 2023). Students who attended college out of state are not included in the data.

Black HS graduates and Hispanic HS graduates achieved this post-secondary completion measure at lower rates than Asian or White students. For the Class of 2017, 39% of Black and 45% of Hispanic high school graduates completed a post-secondary education program within six years, compared to 81% of Asian and 67% of White students.

WHERE DO WE STAND?

In 2024 the annual unemployment rate for Travis County increased to 3.5%, from 2.9% in 2022. A spike in 2020 is from the recession triggered by the global COVID-19 pandemic. In 2024, Austin had the 11th lowest unemployment rate among the 50 largest cities in the nation.

The 5-year unemployment rate for Black residents was 6.7%, which was over 67% greater than the approximately 4% unemployment rate for White residents. The Hispanic unemployment rate was 4.4%. The 5-year rate, from the US Census Bureau, averages rates from 2019 to 2023.

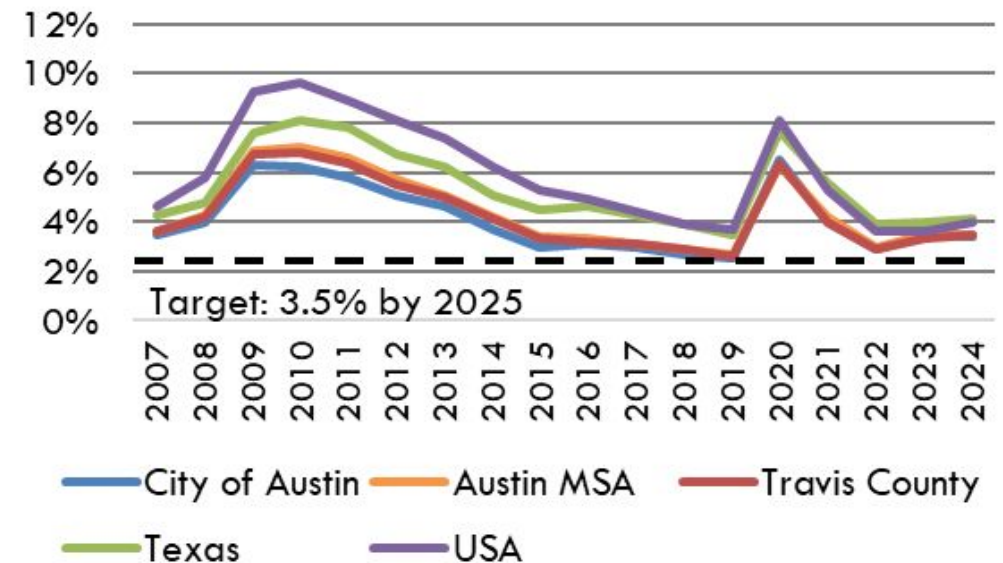
